The proviso to Section 68(2)(c) of the Companies Act, 2013, as amended, and Regulation 4(i) of Buyback Regulations state that the buyback of equity shares in any financial year shall not exceed 10% or 25% of the total paid-up equity share capital of the Company in that financial year with the approval of Board and Shareholders respectively.

The indicative maximum number of Equity Shares to be bought back at the Maximum Buyback Size and the Maximum Buyback Price is 40,00,000 Equity Shares, which is 3.64% (i.e. less than 25%) of the total paid up equity share capital of the Company.
